Flightlease AG in debt restructuring liquidation; Circular No. 8

Ladies and Gentlemen

This Circular provides information on the progress of the Flightlease AG debt restructuring proceedings since the beginning of December 2005, as well as on the next steps planned in these proceedings over the coming months.

REPORT ON ACTIVITIES AS OF 31 DECEMBER 2005 I.

Having been acknowledged and approved by the Creditors' Committee, the third of the Liquidator's reports on activities for 2005 has been submitted to the debt restructuring judge at the district court of Bülach on 28 February 2006. The report on activities will be available for inspection by creditors at the Liquidator's offices at Seestrasse 39, Goldbach-Center, 8700 Küsnacht until 28 March 2006. Appointments must be made in advance with Ch. Rysler, telephone +41 43 222 38 00.

The following is a summary of those points of the report on activities which have not already been covered by one of the Circulars published over the past year.

II. OVERVIEW OF THE LIQUIDATION PROCESS

1. Activities of the Liquidator

Creditors were informed in Circulars No. 4 to 7 about the most important work regarding the liquidation of assets. Once again, the activities of the Liquidator over the past year have concentrated on drawing up the schedule of claims. This work was completed in the summer of 2005 and the schedule of claims was then presented for inspection by the creditors between 13 July and 2 August 2005. Supplement No. 1 was presented for inspection by the creditors between 30 November and 20 December 2005.

Work on investigating potential responsibility claims was pursued in close collaboration with the Creditors' Committee. A first claim, concerning transactions executed through the Swissair group cash pool, was drawn up and filed with the District Court of Bülach (see Circular No. 7, section IV). There was also a review of certain matters associated with the Flightlease AG financial statements as at 31 December 2000. These enquiries are still ongoing.

2. Activities of the Creditors' Committee

The Creditors' Committee held a total of five meetings in 2005. At its meetings, the Committee discussed the various proposals submitted by the Liquidator and passed resolutions accordingly.

III. REALIZATION OF ASSETS

The Liquidator collected accounts receivable of around CHF 770,000 during the period under review. In addition, more MD-11 spare parts could be sold from the stocks that still exist in the USA.

IV. ASSET STATUS OF FLIGHTLEASE AG AS OF 31 DECEMBER 2005

1. Introductory remark

Enclosed is a report on the liquidation status of Flightlease AG as at 31 December 2005, containing a statement of the assets of Flightlease

AG in debt restructuring liquidation as of that date, according to present knowledge.

2. Assets

<u>As-yet unrealized assets</u> consist primarily of claims against former Swissair group companies, participations held by Flightlease AG and an MD-11 spare parts storage facility in the USA. Moreover, any responsibility and avoidance claims are carried pro memoria.

3. Debts of the estate

<u>Accounts payable by the estate</u> reported as at 31 December 2005 concern costs that have been incurred during the debt restructuring liquidation.

Of the <u>provision for the first interim payment</u>, totalling CHF 90,191,848.80, CHF 8,896,654.70 relate to payments that could not be made until January 2006 because creditors were late in submitting their payment instructions to the Liquidator. Meanwhile, CHF 2,443,187.25 relate to interim payments for conditional claims for which the conditions have not yet been met. A further CHF 64,654,211.10 concern interim payments for claims for which an action to contest the schedule of claims is pending. The remainder of the provision – CHF 14,197,795.75 – is for claims that are still suspended at present. The provision that has been made guarantees the maximum amount of all interim payments for all claims that have not yet been assessed.

4. Creditors' claims

Please refer to Circulars No. 6 and 7 for information on the progress on the clearing up of the schedule of claims, as well as a summary of creditors' claims (appendix). No actions to contest Supplement No. 1 to the schedule of claims were lodged.

Meanwhile, the last action to contest the schedule of claims with regard to first-class claims was withdrawn at the main hearing at the District Court of Bülach in February 2006, thereby settling this matter in full.

5. Estimated dividend

The disposable assets reported in the liquidation status give a

maximum dividend of 9%, providing all of the lodged actions to contest

the schedule of claims are unsuccessful and suspended claims are

rejected. Should all of the actions be admitted and the suspended claims have to be recognized, however, the minimum dividend would

be 3.3%.

٧. PLANNED NEXT STEPS IN THE PROCESS

The next phase of proceedings will involve clearing up the schedule of

claims and liquidating the last remaining assets. The liquidation bodies

will focus on pursuing responsibility claims. It is not possible at present

to estimate how long it will take before this issue is settled. Creditors

will be provided with further information in a Circular that is planned

for the autumn of 2006 at the latest.
